Shell Scheme Facilities: ITPO's package of services under Shell Scheme (Commercial Section) in a stand of 9 sq.mtr. built up booth (octonorm system) will include new carpeting floor, spot lights, one podium, fascia, one table, two chairs, one waste basket and one 5 ampere electric socket.. In case of shipment/air freighting and clearance of exhibits, it will be the responsibility of individual exhibitor.

Booking under Bare Space: Before starting construction work, the drawing is required to be got approved from Arch. Division of ITPO. In case of booking of spare space, exhibitors will undertake construction work/decoration work, carpeting in the stall, lighting, furniture and other display aids, etc. at their own cost and risk. The bare space participants are required to pay Rs. 240/- per KW to ITPO, one time Service Connection Charges.
