Following are the Revised Rates for Electricity/Power and other electrical services to be charged from various categories of Consumers at Pragati Maidan w.e.f. 1st October, 2013.

1. Permanent Allottees (Metered Consumers)

Rs. 14.00 per KWH(unit) subject to a minimum of Rs.252.00 per KW per Month of their connected load.

2. State Pavilions, Ministries etc. (Flat Rate Basis)

Rs.168.00 per KW per day Consumption Charges+Rs.190.00 per KW (one time) Service Connection Charges.

- 3. Fairs organized by ITPO and other Agencies where stand lighting and power loads are demanded.
 - a. Stand lighting

Rs. 23.00 per sq. mtr. per day (subject to maximum of 1 KW load per 9 sq.mtr. of Stall area).

b. Power load

Rs.168.00 per KW per day Consumption Charges + Rs.190.00 per KW (one time) Service Connection Charges.

AC charges for Air conditioned Halls

Rs.67.00 per sq.mtr. per day (subject to maximum of 10 hrs/day)

5. Blower operation charges

Rs.3.30 per sq.mtr. per day (subject to maximum of 10 hrs./day).

6. Compressed air charges

Rs.7000.00 per day (available in Hall No.8-11, 12 & 12A only)

SUBJECT: Use of energy efficient CFL/LED lamps in stall lighting in the fairs/exhibitions at Pragati Maidan -- A step towards Green Exhibition 4--.

As measures of energy conservation and making exhibitions ecofriendly, it has been decided by ITPO that:

- 1. Only CFL/LED lamps will be used in stalls as spot lights.
- Use of Halogen and comptalux lamps as spot lights has been totally banned in Pragati Maidan.

Hence all the organisers/exhibitors are requested to use only energy efficient CFL/LED lamps as spot lights in all the events/fairs in Pragati Maidan.

We expect that all exhibitors will comply with the above.

Any exhibitor who does not want to use CFL/LED for any reason may please inform to ITPO in advance with the reasons thereof.
