Each booth of 9 sq.m. under shell scheme will have participation panels, fascia, three spot light, one long armed spotlight, three cabinets, two display shelves, three black leather chairs, one round table/counter, one electric socket, one rubbish bin & carpet. Shipment/Air freight and clearance of exhibits will be the responsibility of individual exhibitor.

The participation Charges are being worked out and are in the vicinity of Rs15,000/sqm(Tentative) with 10% extra for corner charges for a minimum booth size of

9sqm under SHELL scheme.

.The Show is governed by general terms and conditions for participation in international trade fairs.
