(A) Senior Manager (Finance & Accounts): One - by Deputation

Pay-scale: Rs.32900-58000 (IDA pattern) (pre-revised)

Eligibility Criteria:

Age: Not exceeding 56 years.

Age and Experience: Age and experience will be reckoned as on the closing date of receipt of application. Experience will be reckoned on post-qualification basis.

Educational Qualification: Essential:

- (i) Associate membership of Institute of Cost and Works Accountants of India/ Institute of Chartered Accountant
- (ii) Working knowledge of Computer applications.

Experience: Essential: 10 years managerial experience in Finance/ Accounts in Government/ Public Sector/ reputed Private Sector Organisations, preferably in the field of exhibitions.

ITPO does not provide residential accommodation to the incumbent. Perks and allowances applicable to IDA scales will not be applicable to the incumbents whose parent cadre scale is CDA scale. Exemption from the rule of 'immediate absorption' by the Department of Public Enterprises has been requested.

(B) Senior Manager (Security): One (Unreserved) - by Direct Recruitment

Pay-scale: Rs.32900-58000 (IDA pattern) (pre-revised)

Eligibility Criteria:

Upper age limit: 40 years- relaxable upto 5 years for ex-servicemen.

Minimum height: Male: 165 cms, Female: 157 cms. (A certificate from Medical Officer may be attached)

Educational qualifications: **Essential**: Bachelor's Degree from a recognised University.

Desirable: Knowledge of foreign languages, other than English.

Experience: 10 years experience in Armed forces/ CRP/ CISF/ Police/ BSF/ Other paramilitary organisations or Security in Government/ Public Sector organisations, out of which at least 7 years should have been at supervisory level, preferably in the field of exhibitions.

(C) Manager (Security): One (Unreserved) - by Direct Recruitment

Pay-scale: Rs.24900-50500 (IDA pattern) (pre-revised)

Eligibility Criteria:

Upper age limit: 35 years- relaxable upto 5 years for ex-servicemen.

Minimum height: Male: 165 cms, Female: 157 cms. (A certificate from Medical Officer may be attached)

Educational qualifications: **Essential:** Bachelor's Degree from a recognised University.

<u>Desirable</u>: Knowledge of foreign languages, other than English.

Experience: 7 years experience in Armed forces/ CRP/ CISF/ Police/ BSF/ Other para-military organisations or Security in Government/ Public Sector organisations, out of which at least 4 years should have been at supervisory level, preferably in the field of exhibitions.

Note: Age and experience will be reckoned as on the closing date of receipt of applications. Experience will be reckoned on post-qualification basis.

Relaxation in upper age limit for SCs/STs/OBCs/Physically Handicapped/Ex-Serviceman will be as per Government rules.
